



LIABILITY, WAIVER, INDEMNITY & RELEASE AGREEMENT

In consideration of Tradesman Brewing Co. (“Tradesman”) permitting me to bring me dog onto its licensed premises, I (the “Owner”) hereby take action for myself, my personal representatives, heirs, successors, and assigns and agree to the following:

The Owner recognizes and acknowledges that use of Tradesman’s premises and the surrounding areas are for the operation of a brewery and associated activities, which entails certain risks of damage, loss or injury to dogs, persons or property (including the Owner, other persons, the Owner’s dog and other dogs or animals), and the Owner voluntarily agrees to assume the full risk of and responsibility for any injuries, damages, loss, liability, costs and expenses, regardless of severity, extent or amount, that (a) the Owner, his or her dog or any other person or dog accompanying the Owner might sustain or incur as a result of the Owner or the Owner’s dog’s presence on the premises and surrounding areas or the Owner or dog participating in any and all activities connected with or associated with use of the premises and surrounding areas; or (b) any other person or animal might sustain as a result of the Owner or the Owner’s dog’s actions or conduct in connection with or arising out of the Owner’s or the Owner’s dog’s presence on the premises and surrounding areas or the Owner participating in any and all activities connected with or associated with use of the premises and surrounding areas.

The Owner for his or her self, all heirs, executors, administration and assigns, hereby releases Tradesman, its respective directors, officers, servants, agents, or employees from any claims, demands, damages, actions, or causes of action or legal costs arising out of or in consequence of any loss, injury, or damage to other persons, their dogs, or property caused wholly or partly by the Owner or the Owner’s dog for which Tradesman, its respective directors, officers, servants, agents, or employees are claimed or made liable.

The Owner further agrees to indemnify and save harmless Tradesman, its respective directors, officers, servants, agents, or employees from any claims, demands, damages, actions, or causes of action or legal costs arising out of or in consequence of claims by other persons for any loss, injury or damage to them, their dogs, or their property caused wholly or partly by the Owner or the Owner’s dog for which Tradesman, its respective directors, officers, servants, agents, or employees are claimed or made liable.

TRADESMAN APPROVAL:

TERMS & GUIDELINES

1. **Medical.** The Owner of the dog agrees to maintain copies of all pertinent pet medical information and agrees to the following minimum requirements:

- All vaccinations, including bordetellosis, are complete and current.
- Parasite control is being done on a routine basis and the animal is free of ticks and fleas.
- The dog has no recent history (6 months) of infection or ringworm.

2. **Behavior.** The Owner of the dog agrees to observe the following guidelines. Authorization is granted at the sole discretion of Tradesman and can be revoked at any time:

- Owner will be solely responsible for all clean-up on the premises.
- Owner will immediately clean up any accidents or messes using appropriate clean-up and disinfectant measures.
- Owner will not bring to the premises any dog that has not been fully house trained.
- Owner will not bring a dog to the premises that is ill or behaving abnormally and will remove the dog from the premises if it becomes ill while on the premises.
- Owner will not bring a dog to the premises that has bitten or is aggressive, destructive, or excessively vocal, or who has a history of not playing well with other dogs.
- Owner must control the dog at all times using a leash while walking the dog and some form of appropriate containment while on the premises.
- Owner has sole responsibility for care of the dog while on the premises.
- Owner must keep a supply of plastic bags with ties at all times and is responsible for the appropriate disposal of dog waste.
- No dogs will be allowed in the following areas: restrooms, the brewhouse, kitchen areas, offices, food preparation areas, serving and dining areas, mechanical rooms, and such other areas designated by Tradesman.
